Emeritus Diplomate San Antonio Legacy Program Tour

The Legacy Program Tour for 2013 was enjoyed by Emeritus Diplomates and their guests. The tour began with an early lunch at the Tex-Mex restaurant Maria-Mia, located on the Riverwalk where Diplomates and their guests enjoyed a delicious meal.

Following lunch, the group boarded a tour bus and was transported to the Mission San José, one of the earliest missions in Texas.



The tour guide provided a narration of the mission's history and the mission's place in the chronicles of early Texas. The mission was restored by the Works Progress Administration (WPA) in the 1930's and appears much like it did in the 1700's. Following a brief tour of the mission, the group viewed a short movie explaining the history of the mission and the native people of the area.

The next stop included the Buckhorn Saloon and Texas Ranger Museum. The Saloon contains thousands of mounted animals ranging from deer to polar bears, elephants and giraffes. The Texas Ranger Museum provides history of the Rangers and their role in law and order in early Texas. The tour continued to the Alamo, the site of the famous battle resulting in the independence of the Republic of Texas.

After a quick stop at El Mercado,



the site of the original markets in San Antonio, now the largest Mexican goods retail site north of the Rio Grande River, the group returned to the hotel for the Celebration of Surgical Success reception.

Most participants agreed that the appeal of each location warranted even more time to explore. The Legacy Program Tour provided an interesting introduction to San Antonio's past and some of what the entire city has to offer today, as well as a fun opportunity to reconnect with friends and colleagues.
